Enrollment Agreement and Cancellation Policies

Enrollment is for a 10-month program (August–May) with monthly tuition from mid-August to mid-May.

A non-refundable \$55 registration fee (per child) secures your child's spot in the Fun and Play School program.

Tuition is \$205 per month, billed on the 1st and due by the 5th of each month; payments after the 15th incur a \$25 late fee. Siblings attending at the same time receive a discounted Sibling Rate of \$185 per sibling per month.

If you need to withdraw early, your account must be current and you must give at least two weeks' written notice. Otherwise, a \$75 withdrawal fee plus any outstanding balance will apply.
